<u>Chairmans Report</u> B.Mayhew gave a brief account of what has happened since the last meeting and also the problems that Coronavirus has caused the Club. He was very pleased with the turn out for the roll-ups since the restrictions were lifted and stated how all the members who attended had enjoyed their bowling. He praised the way in which all members had used the sanitising products and for the way members had conducted themselves throughout. He also outlined the problems on how the virus had effected the way in which the Club operates in not being able to hold full committee meetings as well as having to cancel our AGM for this year.

Treasurers Report P.Mead told the meeting that the Club had made a profit of £8393.48 this year but stated that we have pledged £3,000 towards the cost of the new storage area and we still had to replace some equipment at a cost of approximately £1000. He said he would like to increase the playing membership to £30 next year and the joint membership to £50. He said that he felt there was no need to increase the match fees that would remain at £2 home and away and £3 if there was food supplied at home games. The committee agreed to this. Also Bowls England had re-inbursed the Club with all fees that had been paid i.e Affiliation and individual completion fees as well as team competition fees. These would be paid back to those members who had contributed. He said he would give a full report when we sent out details from the questionnaire. He said P.Wright had audited the books.

<u>Groundsmans Report</u> J.Gill said that the top dressing will be applied within the next few days and also the problems of the worm casts would be treated also. He also spoke about the possibility of having the green levelled by an expert and he would find out further details and report back to the committee
